Announcement by the Secretary General

Fellowships

The ISLSSL can offer up to ten fellowships, each worth up to u\$s 1,000 to help young scholars who wish to attend the Congress. Below are the qualifications to apply:

- (a) Deadline: Applications must be submitted to me <u>no later than 30 June 2006</u>. Priority will be given to applications supported by a National Member of the ISLSSL;
- (b) Age: less than 40 years old. Priority will be given to applicants aged less than 35 years old;
- (c) Nationality: Priority will be given to applicants from weak currency countries;
- (d) Language proficiency: Fully satisfactory knowledge of one of the working languages of the Congress;
- (e) Non eligibility of former beneficiaries of ISLLSS fellowships: Those who have already received an ISLLSS fellowship are not eligible;
- (f) Submission of a communication: Successful candidates are required to submit a communication or a paper on one of the themes of the Congress;
- (g) Gender: Applications from both male and female candidates are equally welcomed; applications from female candidates are encouraged.

ISL&SSL bursaries will not be required to pay registration fees.

4. IX European Congress of ISL&SSL, 2008

I have received the following proposals from the Organizing Committee, which is chaired by Professor Manfred Loewisch.

Date and venue of the Congress: 16-18 September 2008, in Freiburg, Germany.

Agenda:

<u>Theme 1</u>: The realization of the equal treatment principle in employment and occupation in the European Union Member States

The theme would be focussed on the transposition and implementation of Council Directive 2000/78/EC of 27 November 2000 establishing a general framework for combating discrimination on the grounds of religion or belief, disability, age or sexual orientation as regards employment and occupation, with a view to putting into effect in the Member States the principle of equal treatment.

The following sub-themes would be dealt with:

- o Measures taken in the EU Members to transpose the Directive,
- How is the Directive implemented in practice (laws and regulations, other policy measures, case law, collective agreements, social dialogue)? and
- o Exceptions to the application of the equal treatment principle.

Theme 2: Status and protection of migrant workers

The following questions might be tackled:

- (a) Migration within EU Members
- (b) Migration from non EU-Members (Management of migration by EU Member States)
- (c) Illegal migration
- (d) The role of trade unions.

<u>Theme 3</u>: The impact of aging on pension schemes in Europe

Round Table 1: The impact of information and communication technologies in the field of labour law.

Round Table 2: (The subject will be proposed by the Spanish Association for Labour Law and Social Security).

Workshop 1: Systems of law enforcement in labour law.

Workshop 2: Qualification and training of legal assistants in labour law

The Executive Committee will be asked to adopt the agenda and appoint the reporters at its forthcoming meeting in Paris, September 2006.

5. International Seminar on Comparative Labour Law, Industrial Relations and Social Security, Bordeaux, France.

Professor Auvergnon has confirmed that the next edition of this Seminar will be held from 3 to 13 July 2006. Its general topic will be: <u>Gender and Labour Law</u>. The working languages will be English and French. Registration fees are \in 375 (u\$s 450) without accommodation and \in 750 (u\$s920 with accommodation and breakfast). Fellowships

The ISLSSL can offer up to five fellowships, each worth up to €750 to cover registration fees and accommodation. Below are the conditions to apply:

- (a) Deadline: Applications must reach me <u>no later than 31 st May 2006</u>. Priority will be given to applications supported by a National Member of the ISLSSL;
- (b) Age: No more than 40 years old. Priority is given to applicants aged less than 35 years old;
- (c) Nationality: Any. Priority is given to applicants from weak currency countries;

- (d) Language proficiency: Fully satisfactory knowledge of either French or English;
- (e) Non eligibility of former beneficiaries of ISLLSS fellowships: Those who have already received an ISLLSS fellowship are not eligible;
- (f) Gender: Applications from both male and female candidates are equally welcomed; applications from female candidates are encouraged.

6. Election of the Secretary General and the Treasurer

In keeping with the ISLSSL by-laws the Executive Committee shall elect a Secretary General and a Treasurer of our Society for a three-year term, until 2009. The election is to take place during the forthcoming Executive Committee meeting in Paris, 5 September 2006.

The procedure for the election is addressed by article 9 of our by-laws:

Article 9

- 1. ...
- 2. The Vice-Presidents, the Secretary-General and the Treasurer shall be appointed by the Executive Committee at its meeting that normally takes place immediately before each World Congress. In order to apppoint the Secretary-General and the Treasurer, the Secretary-General shall issue a call for nominations not less than six months prior to this meeting, and the nominations shall reach him or her not less than three months prior to that meeting.

A call for candidatures has been sent to our National Associations. The deadline for the submission of candidatures is 5 June 2006.

7. Financial Questions

Apart from Secretarial support provided by the ILO, our Society relies entirely on the dues paid by our members. It cannot survive if they are not paid. As usual, I have made a call by the end of last year, for our members to send their contributions to our Treasurer. I am very pleased to inform that most of our members have by now paid their dues for 2005.
