XVIII World Congress of ISL&SSL, Paris, September 2006

I am pleased to convey my warm thanks and congratulations to Professor Antoine Lyon-Caen and all his team for the wonderful World Congress we have had in Paris, from 5 to 8 September 2006. It was indeed a great event, attended by some 1,000 participants from some 60 countries of all regions of the world.

The congress examined three major themes, as following: (a) Trade Liberalization and the Labour Law; (b) Productive Decentralization and the Labour Law, and (c) Occupational risks. I congratulate our general reporters, Professors Compa (US), Perulli and de Luca Tamajo (Italy), Numhauser-Henning (Sweden) and Cissé (Senegal) for the state of the art reports they submitted on their respective subjects.

A round table, on the role of statutory regulation in Labour Law was also held during the Congress, which permitted to compare European, North American, Latin American and Australian labour law patterns and trends. It was moderated by Professor Catherine Barnard (UK).

Some seventy national reports and many individual papers were submitted to the congress. Many workshops were held, which permitted very lively debates. Everybody agreed that this was a highly succesful formula, which should be taken up in forthcoming ISL&SSL events.

Interpretation into/from French, English, Spanish, German and Italian was provided in all plenary sessions, the round table and one workshop each day.

1. Meeting of the Executive Committee, Paris, 5 September 2006
