News from our Society

1. VIII Regional Americas Congress of ISL&SSL, Cartagena de Indias

I am very pleased to convey my deep thanks and warmest congratulations to our Colombian colleagues of the Colegio de Abogados del Trabajo for the impeccable work they have done in organizing this highly successful Congress.

The Congress was held at the Convention Center of the City of Cartagena de Indias from 25 to 28 May 2010. It took place together with the XXVIII National Congress of Labour and Social Security Law of Colombia and was attended by more than 550 participants, of whom some 100 participants came from countries other than the host country. English and Spanish, with interpretation were the working languages of the Congress.

The Congress agenda included the following themes:

Theme 1: Current situation and the future of public and private pension systems in the light of the worlwide crisis.

Theme 2: Public and private systems of settlement of individual and collective labour disputes.

Theme 3: The protection of worker's privacy at the workplace.

The Congress also held two Round Tables, respectively on the impact of the socalled "news forms of employment" on individual and collective employment relations, and on the use of International Law in domestic courts.

3. XX World Congress of ISL&SSL, Santiago de Chile, 2012

The Congress will be held in the week beginning September, 24, 2012.

The following agenda has been agreed upon between the Organizing Committee and the officers of ISL&SSL

Theme II: Mobbying and sexual harassment at the workplace.

Theme III: Strike as a fundamental right and its possible collision with other

fundamental rights of the citizens.

In addition, there will be two Round Tables or workshops, the themes of which would be fixed at a later stage (ie. at the forthcoming Executive Committee meeting in Seville, 2011).

Consultations are underway relating the selection of the general reporters.

4. Task force Servais

Our Honorary President Jean-Michel Servais is undertaking consultations on the format of our congresses and our Society endeavours to attract new members. He has prepared a paper and a questionnaire, which was sent to our Honorary Presidents, Vice-Presidents and a number of other members. He has already received many replies and is expected to submit a report and proposals to our Executive Committee while at its next year meeting in Seville.

5. Questionnaire on National Members of ISL&SSL

You may remember that at its General Assembly in Sydney, September 2009, a number of amendments were made to our by-laws, which included criteria to define which national association would be eligible to become "national members" of our Society, with full voting rights. The relevant rules were drafted as following:

Quote

Article 3

The Society membership shall consist of:

1 National associations or other entities which have decided to affiliate themselves as members of the Society and whose affiliation is accepted by the Executive Committee. This category of membership shall be referred to as the Society's National Members. To be eligible, a National Member shall submit its by-laws or a brief on its purpose and activities and shall demonstrate that it has no less than 15 dues paying individual members. The Executive Committee may, however, accept a smaller number of members of an association in order for it to qualify as a National Member if that smaller membership is justified because of the applicant's individual situation. There shall be no more than one National Member per country. ...

Unquote

The new by-laws also provided that the Officers in consultation with the Vice-presidents would propose a list of the associations that met the criteria for being recognized as National Members pursuant to article 3.1 above, which list would be submitted to the approval of the Executive Committee at its next meeting, in 2011, Seville.

In keeping with these rules I have sent a questionnaire to all of our Executive Committee Members, to ask them to provide information on their respective associations, including the number of their individual members, their steering boards, their publications and other activities.

I have so far received replies from our member associations in the following countries: Argentina, Australia, Belgium, Brazil, Colombia, Croatia, Czech Republic, Finland, France, Morocco, Peru, Philippines, Souzth Africa, Sweden, Turkey and US.

I urge our members that have not yet replied to send me their replies at their earliest convenience.

6. International Seminar on Comparative Labour Law, Industrial Relations and Social Security

As you know, this Seminar, which is co-sponsored by our Society was held between 2000 and 2009 in Bordeaux, France. We have now received several expressions of interest to organize a similar Seminar in 2011 and thereafter fthe Universities of Krakov (Poland), Leuven (Belgium) and Lyons (France). The Universitas Foundation (Venezuela) is also exploring the possibility of convening a high level seminar in Venezuela. I will keep you informed of any further development.
