#### **Uruguay**

I very much regret to announce the death of Professor Oscar Ermida Uriarte on June, 7, 2011. He was undoubtedly one of the leading Labour Law experts in his country and in Latin America, and was very well known through his impressive record of publications and participation in international meetings on Labour and Employment Law. He was a former President of the Uruguayan Association for Labour and Social Security Law and a Member of the Iberoamerican Academy of Labour and Social Security Law. Between 1986 and 2005 he worked for the ILO, first as a Regional Adviser in Labour Law an Labour Relations at the ILO Regional Office in Lima, and thereafter as Project Director of RELASUR, Montevideo, Specialist on ILO Standards and Labour Relations in Santiago de Chile and Deputy Director of CINTERFOR, Montevideo. In 2005 he resigned from ILO to take up a full time position as Professor of Law at the Universidad de la República, Montevideo. We will especially remember him for his role as a General Reporter at our

#### 6. ILO

At its 100a Session, June 2011, the ILO Conference adopted a new Convention (no 189) and a new Recommendation (no 201) on domestic workers. The new ILO standards set out that domestic workers around the world who care for families and households, must have the same basic labour rights as those available to other workers: reasonable hours of work, weekly rest of at least 24 consecutive hours, a limit on in-kind payment, clear information on terms and conditions of employment, as well as respect for fundamental principles and rights at work including freedom of association and the right to collective bargaining.

Recent ILO estimates based on national surveys and/or censuses of 117 countries, place the number of domestic workers at around 53 million. However, experts say that due to the fact that this kind of work is often hidden and unregistered, the total number of domestic workers could be as high as 100 million. In developing countries, they make up at least 4 to 12 per cent of wage employment. Around 83 per cent of these workers are women or girls and many are migrant workers. The Convention defines domestic work as work performed in or for a household or households. While the new instruments cover all domestic workers, they provide for special measures to protect those workers who, because of their young age or nationality or live-in status, may be exposed to additional risks relative to their peers, among others.
