## ***IX Regional Congress of the Americas***

Together with our President Elect, Professor Goldin, we met in Buenos Aires with Professor Sabino Hernández, Chair of the Organizing Committee, to start discussing organizational details and Congress Agenda. ### **Austria**

I very much regret to announce the death of Professor Karl Spielbüchler, on January, 9, 2012 at the age of seventy-two. He was president of the Austrian Society for Labour Law and Social Security since 2001 and had acted before as its Vice-president since 1983. Professor Spielbüchler started as a civil law judge; he was appointed Full Professor of Civil Law at the University of Linz in 1973 and became a Judge at the Austrian Constitutional Court in 1976 at the age of 37, where he served until 2009 (the longest term ever held there). Since the beginning of his academic career he actively dealt with

Labour Law, a domain in which he authored an outstanding book on Individual Labour Law and several influential articles. Besides, he contributed much to the doctrine of civil law and influenced the development of constitutional law.

I have conveyed my condolences to our Austrian colleagues and asked them to also forward my condolences to Professor Spielbüchler's family.

I have the great regret to announce the death of Professor Guillermo López Guerra in Bogota, at the age of 85.

## France

I have also sad news from France. Professor François Gaudu, President of the *Association Française de Droit du travail et de la sécurité sociale, AFDT* died on January 3, 2012 at the age of 58. Below is his obituary published on AFDT's webpage:

François GAUDU est décédé le 3 janvier, vaincu par la maladie. Il semblait pourtant invincible, tant il donnait l'image de la force, celle que donne l'engagement dans l'action.

Son action avait l'Université pour domaine éminent. Agrégé d'histoire, il s'était ensuite tourné vers le droit. Un doctorat de droit, préparé sous l'œil bienveillant et souvent admiratif de Gérard Lyon-Caen, l'agrégation de droit privé, son parcours académique fut brillant. Il aimait d'ailleurs vanter les mérites de ces concours qui éloignent en principe des pratiques népotiques.

S'il était un savant, un juriste épanoui, un « juslaboriste » connu ici et ailleurs, il était avant tout un grand universitaire. Il aimait l'institution universitaire et les lumières qu'elle apporte. Professeur à l'Université du Maine, puis à l'Université de Cergy-Pontoise, avant d'être appelé à l'Université de Paris I, où il avait fait ses débuts, il ne refusait jamais d'apporter son concours à une réflexion critique, à une réforme ambitieuse, à la gestion des universités. Il aimait l'enseignement, passant d'un amphithéâtre bondé de première année à une salle de séminaire, avec un plaisir jamais démenti. Il est vrai qu'il avait tous les dons : d'une belle voix forte, il savait tour à tour dresser une fresque historique, proposer l'analyse d'un dispositif juridique, dénoncer les erreurs commises, tracer des perspectives...

Il alliait pédagogie et sens critique. Ainsi avait-il, de temps à autre, publié des ouvrages destinés à l'apprentissage, tels son « Que sais-je » Les 100 mots du droit ou son Cours de droit du travail. Mais il avait une pensée puissante. Ses livres - on songe au traité sur Les contrats du travail, dont il est le co-auteur. - et ses nombreux articles sont le fruit d'une remarquable combinaison : une vaste culture historique donnant plus de place aux forces qu'aux individus, une intimité profonde avec l'outillage du droit et une capacité hors du commun d'interpréter le droit et son évolution. Et couronnant le tout, une conviction. Car François GAUDU était homme de conviction. Qu'il s'agisse de l'ampleur du rôle que le droit occupe dans la construction et le fonctionnement du marché du travail, des libertés dans les lieux de travail, et notamment de l'importance du respect mutuel, qu'il s'agisse encore du rôle de la volonté ou de l'importance de la négociation collective, comme des grandes mutations du capitalisme contemporain dans leurs incidences sur la condition des travailleurs, il livrait des analyses vigoureuses, d'où les propos convenus étaient absents. Jamais de fadeur, toujours les épices critiques.

Son sens critique était aiguisé par son adhésion profonde aux valeurs de la République. Il y puisait d'ailleurs une énergie toujours renouvelée, celle qu'exige le combat contre les menaces qui pèsent sur notre savoir-vivre ensemble.

Authentique républicain, grand universitaire, savant, original, il excella dans des activités difficiles, auxquelles peu de juristes universitaires consacrent du temps et de l'énergie, l'animation de la recherche, notamment auprès de feu le Commissariat au Plan et du Ministère de la Recherche.

Mais ce à quoi il était mieux préparé que d'autres, par ses goûts et talents personnels, par son milieu familial, c'était à l'ouverture au monde. François GAUDU inscrivait son travail dans les dimensions d'un monde décloisonné, dont il saisissait les déséquilibres et les injustices. Nombre de ses travaux ont montré la corrosion des institutions par la libéralisation mal maîtrisée des échanges. Et il faisait entendre une voix originale dans les multiples séminaires et conférences auxquels il était convié en Europe et en Asie.

Et lorsqu'en 2009, l'Association française de droit du travail et de la sécurité sociale en fit son président, il manifesta, dans ses propos et ses actions, l'importance qu'il attribuait à l'inscription de l'Association dans le réseau mondial des spécialistes du droit social. C'est une grande et belle figure de l'Université et du droit du travail qui vient de disparaître à 58 ans. Elle va manquer en ces temps tourmentés.
